Habitat for Humanity New York City and Westchester County, Inc. and affiliates (Habitat NYC and Westchester) (EIN: 11-2857055) is required to complete and submit tax, financial, and statistical reports to donors, the government, and general public on an annual basis. Habitat NYC and Westchester adheres to all legal and ethical financial practices.

Habitat NYC and Westchester is comprised of approximately 30 affiliates. Habitat NYC and Westchester is the main entity; the majority of the affiliates are HDFCs created in order to bring benefits to affordable housing. These affiliates file their own Form 990, however should all be viewed as one consolidated entity. Below are the affiliates with significant activity which impact Habitat NYC and Westchester's expense ratios:

- 1) Habitat Queens Phase II Housing Development Fund Corporation (EIN: 81-1242655)
- 2) Habitat for Humanity Dean Street Housing Development Fund Corporation (EIN: 46-404465)
- 3) Habitat for Humanity Housing Development Fund Company, Inc. (EIN: 12-3977866)
- 4) Habitat for Humanity NYC Fund, Inc. (EIN: 38-4028626)

Additionally, Habitat NYC and Westchester has two active LLCs (partnerships) for two major construction projects. These entities file Form 1065 (partnership tax returns). All unit sales are flowing through these LLCs:

- 1) AG Habitat Tilden Street LLC (EIN: 81-1242655)
- 2) Habitat Latent LLC (EIN: 47-5242503)

Per federal and state regulations, each entity files its own tax return on an individual basis, with specific exceptions. The tax returns include information such as the balance sheet, profit & loss, statement of program service accomplishments and compensation of officers and directors. Certain items, such as cost of sales, contributed services and unrealized gain/loss are treated differently for tax purposes than on the audited financial statements; these items are netted on the 990 but grossed up on the audited financials.

In summary, the FY 21 ratios on both the tax returns and audited financials reflect operational efficiency and compliance. For example, as per Schedule A, Part II on page 16 of Habitat NYC and Westchester's Form 990, approximately 94% of the Habitat NYC and Westchester's funding was from public support for the last 5 years. In addition, the FY 21 internal financials state the 5-year average for expenses were 79% program, 13% management & general and 8% fundraising, which are all very strong ratios.


