BY PARTNERING WITH TENANT-OWNED AFFORDABLE BUILDINGS, HABITAT HELPS PROTECT LONG-TERM AFFORDABILITY AND STRENGTHENS COMMUNITIES FOR THE FUTURE. OUR HOUSING PRESERVATION PROGRAM IS A HOLISTIC PROGRAM THAT WORKS WITH INDIVIDUAL BUILDINGS ON THEIR SPECIFIC NEEDS, PROVIDING LOW-COST SERVICES INCLUDING CONSTRUCTION, FINANCIAL EDUCATION, LEGAL MONITORING, AND MORE. THE RESTORE ACCEPTS DONATIONS OF NEW AND GENTLY USED ITEMS SUCH AS FURNITURE, APPLIANCES, HOME DECOR, AND BUILDING MATERIALS TO SELL AT REDUCED PRICES. BY THE END OF THE FISCAL YEAR ENDING JUNE 2025, THE RESTORE DIVERTED 3,325 TONS OF WASTE FROM THE LANDFILL.
